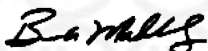

Illuminated Mushroom Push Buttons - Cat. Nos. 800F or D7, followed by P or M or N, followed by -LMM, -LMT or -LMP, followed by suffixes.

Non-Illuminated Multi-Function Push Buttons - Cat. Nos. 800F or D7, followed by P or M or N, followed by -U2 or -U3, followed by suffixes.

Illuminated Multi-Function Push Buttons - Cat. Nos. 800F or D7, followed by P or M or N, followed by -LU2, followed by suffixes.

Non-Illuminated Selector Switches - Cat. Nos. 800F or D7, followed by P or M or N, followed by -H or -S, followed by B, L, M, or R, followed by 2, 3, or 4, followed by suffixes.

Illuminated Selector Switches - Cat. Nos. 800F or D7, followed by P or M, followed by -LH, -SJ or -LS, followed by B, L, M, or R, followed by 2, 3, or 4, followed by suffixes.

Non-Illuminated Key-Operated Selector Switches - Cat. Nos. 800F or D7, followed by P or M or N, followed by -KB, -KE, -KL, -KM, or -KR, followed by 2 or 3, followed by suffixes.


Pilot Lights - Cat. Nos. 800F or D7, followed by P or M or N, followed by -P, followed by suffixes.

Reset Push Buttons - Cat. Nos. 800F or D7, followed by P or M or N, followed by -R, followed by suffixes.

Toggle Switches - Cat. Nos. 800F or D7, followed by M or N, followed by -J, followed by M or R, followed by 2 or 4, followed by suffixes.

Toggle Switch Boots - Cat. Nos. 800F or D7-ABJN or 800F-ABJS.

Selector/Jog Switches - Cat. Nos. 800F or D7, followed by P or M or N, followed by -S, followed by J, followed by 2 or 3, followed by suffixes.


Potentiometers - Cat. Nos. 800F or D7 P-POT, Series A or B.

All devices are Series A unless otherwise specified. Mushroom pushbuttons with suffix MP, LMP and LMT are Series B.
